The two half (12.5 mm wide) blanks supplied with the Double Gang Faceplate allows spacing options for mounting three jacks or shutters in the faceplate.

The colour options permit the assembly of the telecommunication outlets to contrast with the wall finish if required to comply with the Equality Act 2010 and Part M of the Building Regulations.

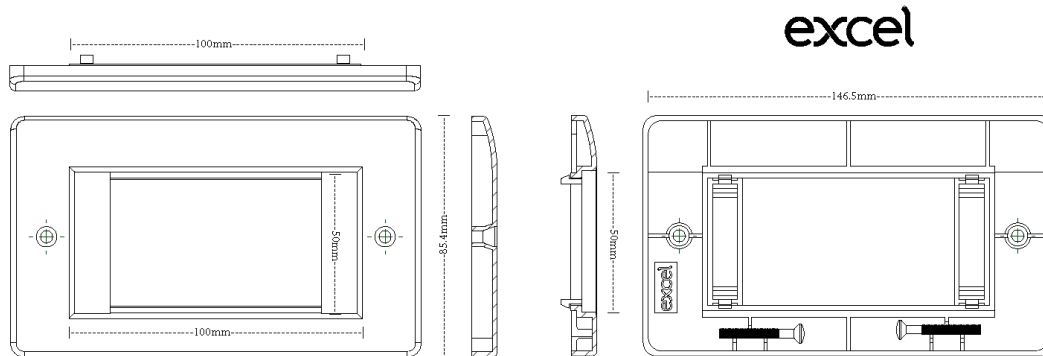
